### **Surface Preparation:**

Surfaces must be dry, free of dirt, loose particles, oil, wax, grease or any other substance, which may affect adhesion. In some cases concrete, stone, ceramic and masonry surfaces may need to be ground or sandblasted. If wood surfaces have been previously coated / painted, this material should be scraped off to expose the clean wood surface. Similarly, metal surfaces need all oxidized / rusted areas cleaned away. Aluminum framing is often clear-coated to prevent oxidation; this must be removed prior to bonding.

## **Application:**

Cut the appropriate spout size and break the seal of the tube, then apply using a caulking gun. It is the users responsibility to check the adhesion of the cured material. Extruded material can also be spread with a trowel. Clean any excess material with mineral spirits before curing. Misting the applied adhesive with water will increase its cure speed. If the HiLoc is misted with water after it is applied to the tackstrip, it is possible to power-stretch carpet after two hours.
